## Highways Act 1980 Section 31 (6)

A deposit has been entered into the Register of Deposits and Declarations under the above legislation, the deposit within Martham, Fleggburgh, Rollesby, Filby, Mautby, Acle, Stokesby with Herringby, Halvergate, Great Yarmouth, Ormesby St. Michael, Ashby with Oby, Freethorpe and Reedham has been given the reference number **D22 02** with the deposit date **06/12/2021**. I therefore thought it would be useful to provide you with some information regarding the deposit.

Deposits made under Section 31 (6) of the Highways Act 1980 relate to the establishment of public rights of way. A deposit relating to public rights of way does not affect any existing public rights of way that are recorded on the definitive map and statement; the public can continue to use existing public rights of way as normal. The deposit is a statement from the landowner that they do not intend to dedicate any *additional* public rights of way over their land. An admission by the landowner of existing rights of way usually forms part of the deposit.

Dear Parish Clerk,

You may be aware that the Government have now issued their response to "The Landscapes Review" (The Glover Report).

The Broads are mentioned under several headings.

The Broads Society, a Registered Charity and an official consultee to the Broads Authority on Planning Applications, have been monitoring, along with the Campaign for National Parks (The umbrella Charity for all of the English & Welsh National Parks) the progress of this review.

Around 14 Parishes within the Broads Authority Executive area are currently members of The Broads Society but this information is going to all Parishes in the areas effected as we consider that actions following the Consultation are likely to have long term implications for Parishes & residents.

The consultation includes Local Representation which currently varies across the National Park Family, especially where, like The Broads a number of County, City & District Councils are involved.

The online consultation closes on 9<sup>th</sup> April and is open to both organisations and individuals.

Chapter 4 Page 12 are most relevant & Q21 of the Consultation.

The local media have only (so far) picked up on one aspect, (enforcement of Bye-Laws) but it is much wider than that.

We would be pleased if this information could be passed to your members for due consideration.

We will of course be submitting a response & any feedback would be appreciated.
